- Monitors and manage Safety Work Program of subcontractors by regular inspections of SITE.
- Conducting Safety induction and training for the employees, Subcontractors and Visitors.
- Develop training program in compliance with client and subcontractor needs
- Act as advisor to job site supervisor in all safety matters of the project management team and subcontractors as required
- Ensure all Work force are Supplied with adequate and proper PPE and ensure proper usage, give relevant training.
- Participate all the Safety Meeting and inform Employees and Management about the issues discussed.
- Ensure PTW for high risk activities on SITE, like hot work, confined space entry, live electrical works, LOTO etc.
- Recording and investigation of accidents of injuries, damage and production loss.
- Prepare, record and communicate HSE related daily, weekly and monthly reports and statistics.

- Maintain updated HSE signs and bulletin boards on SITE showing most recent statistics and information.
- Participating and facilitating Safety audit on site, and HSE review meeting.
- Participate in Site safety walkthrough with client and giving instruction on the spot to job supervisors and Safety officers for immediate rectifications.
- Conducting and participating HSE “TOOLBOX” talks.
- Checking and monitoring the Scaffolding tag system.
- Inspection workplace on daily basis to ensure all the control measures are in place.
- Ensure good housekeeping on SITE specially before end of shift, and ensure all high hazard areas are barricaded for access control.
