- Implementation of Safety, Health, Environment & Security Procedures & Regulations of the Project in accordance with DM, JAFZA and client's recommendation.
- Strict implementation of existing Safety Rules and Regulations relevant to construction.
- Organize safety inspection, safety patrols, prepare site meeting at different levels and timings and organize training session on safety with the different levels of supervision and execution.
- Enforce implementation of safety regulations, to upgrade safety where possible along with the progress of the project, inspect working areas to detect and correct unsafe / unhealthy situation and to organize education and sensibleness of the workforce.
- Ensure that appropriate fire equipment is available in good working condition and that established emergency procedures are in place in the event of fire or other emergency.
- Ensure that works start only after obtaining work permits approved method of statements, drawings and other obligatory safety requirements.
- Explain to all employees that hazards inherent in a particular work area, especially to new employees and that Safety Officer should give induction to them.
- Close supervision of any overhead activities and that advice staff and workforce about the potential risk.
- Responsible to deal with emergencies and monitoring of quality records for safety and fire prevention equipment.
- Safety supervisions, safety inspection, accident monitoring and technical report writing through daily, weekly, monthly & yearly accident and injury reports.
- Providing Induction and regular Tool Box Training to all employees as per their concerned activities.
- Communicating HSE Policy throughout the Organization and ensuring its implementing as per site requirements.
- Ensuring an effective safety program is available and understood by personnel.
- Initiate corrective & preventive action to avoid accident.
- Preparation of inspection checklist as per site activities and safety requirements.
- Ensuring regular safety inspection conducted at the workshop and site location.
- Planning and implementation of accident prevention program.
- Inspection of Heavy Plants and Vehicles.
- Inspection of all temporary electrical installations.
- Accident investigation and reporting.
- Inspection of lifting equipments.
- Conducting HSE committee meeting.
- Corresponding with management for better implementation of Safety Standards.
- Identifying needs of Personal Protective Equipments and ensuring their use and availability.
- Enforcing and monitoring of Personal Protective Equipments regularly at site.
- Supervising specific hazards operation.

- Assisting the site line management about all major and critical safety issues.
- Providing, implementing and monitoring fire and emergency procedures at site.
- Enforcing tagging system to all safe / unsafe support system, power tools and lifting equipments...etc.
