- + Implementation of Health, Safety and Environmental policy and those related to the clients, customers and local authority.
- + Carry out survey and inspections on a regular basis in association with supervisors to ensure that safe working practices are in operation.
- + Assist HSE managers in the training for all levels of employees to promote awareness of injury, fatality and occupational disease prevention and damage control.
- + The preparation of safety and health documentation requirements, compiling the project safety plan/manual and all related procedure.
- + Ensuring that all safety equipment and personal protective clothing on the project is suitable to use
- + and complies with the approved standard.
- + Conducting safety inspections on site/plants as per procedure, and providing recommendations and information to the responsible manager or his designate.
- + Implementation of emergency plans with respect to different emergencies like accident, fire etc.
- + Conducting site safety inspections and ensuring that any safety violations observed are immediately corrected and that the employees responsible for the violation are educated and supervisors cautioned and instructed on the proper method of work.
- + Compiling, maintaining and reporting about subcontractors, supplier's safety performance.
- + Conducting joint safety inspections with the contractor's representatives within their areas of responsibility and assisting them in providing on the job safety training (toolbox talks) for their employees when required.
- + Liaise with Site Management to ensure that all work is planned and conducted safely, and in the case of accidents liaise with local medical staff and complete the accident or incident investigation report. Assist in conducting accident investigations.

- + Providing toolbox talks and training on all health and safety requirements on site including instructions on the use of safety equipment, personal protective equipment.
- + Ensuring all government regulations concerning safety, environment and health are implemented in the execution of the project.
- + To check and ensure first aid facilities available are adequate at site.
- + To ensure sufficient PPE is available in store.
- + To prepare the emergency evacuation plan for the site and to upgrade it in regular intervals.
- + Health & Safety hazards and Risk assessments for all activities and suggesting the practical solutions.
- + Prepare monthly statistics reports and submit to HSE Manager.
- + Liaise with local medical staff, monitor and analyze injury-reporting system.
