- Conduct weekly safety meeting.
- Make observations for any unsafe condition and unsafe work and get corrections immediately.
- Inspect Equipment & tools for any damage.
- Checking work permits.
- Coordinate with the first Aider & Emergency response team.
- To get All work carried out with safety according to the entire satisfaction of client.
- Discussing the last mistake made by the workers and giving them awareness to avoid accidents and near misses.
- Inspection of scaffolding ladders, tags.
- Provide awareness about safety among workers.
- Daily inspection of Transport, Construction Equipment and lifting
- Making daily reports regarding unsafe procedures in job site and prevent step to avoid recurrence.
- Gas test in confined space and also inspection of equipment.
- Inspection of work site daily and report to HSE Supervisor/Manager.
- Checking and monitoring the scaffolding tag systems.
- Before leaving the job site, make sure the housekeeping of all the jobs area.
- Keep a record of HSE related issues and documents.

- Communicate safety rules and standards to the workforce
- Enforces all working crew to wear appropriate PPE during entire course of the job
Implements lessons learned from incidents, safety audits and reviews/ incident trending analysis.
- Ensures all mechanical and heavy equipment operator have a valid Saudi Aramco certification and it is compatible to the equipment being used.
- Verifies all heavy equipment, lifting equipment, slings and rigging hardware have valid 3rd party certificates and daily inspected prior to use/operate.
- Conduct daily work site inspection to identify and immediately correct unsafe acts and conditions.
- Push for the necessity of welfare facilities at the site for crew workers such as provision of toilets, wash basins, food, smoking & rest shelters etc.
- Immediately report all incidents, unsafe conditions and defects in equipment to the contractor site management and SAPO.
- Target to achieve “Zero accident/Incident” Goals.
- All other responsibilities related to the function.
