- Daily, Weekly, Monthly, Quarterly Inspection and monitoring all activities and facilities.
- Attending the meetings of various internal and external part of the project where the safety is one of the main issues. Attending weekly Safety Walkthrough with the Client and rectify the outstanding/Pending issues.
- Preparing health and safety strategies and developing internal policy.
- Carrying out risk assessments and considering how risks could be reduced.
- Outlining safe operational procedures which identify and take account of all relevant hazards.
- Carrying out regular site inspections to check policies and procedures are being properly Implemented.

- Leading in-house training with managers and employees about health and safety issues and risks.
- Keeping records of inspections findings and producing reports that suggest improvements.
- Producing management reports, newsletters and bulletins.
- Ensuring the safe installation of equipment.
- Advising on a range of specialist areas, e.g. fire regulations, hazardous substances, noise, safeguarding machinery and occupational diseases.
- Making daily reports regarding unsafe procedure in job site and preventive steps to avoid recurrence.
- Attending tool box meeting of sub-contractors to assure that they are discussing safety procedure.
- Delivering tool box talk with the job supervisors daily before start of work.
- Inspection of scaffolds, ladders, trenches and excavations to ensure safe execution.
- Inspection of workers and equipment's in the job site to ensure proper safety procedure as per client's satisfaction.
- Coordination with the client's safety department regarding safety procedure in job site.
- Discussing the latest mistakes done by the workers and giving them awareness to avoid accidents and near misses.
- Inspection of work site on daily basis and report to HSE Manager.
- Inspection of firefighting equipment's and submission of report to HSE manager.
- Monthly inspection of tools and equipments to ensure that color code is done.
- Conducting emergency evacuation drill.
- Preparation of Job Safety Analysis and Implementing Company and Client safety policies.
- Inspection and safety precautions for electrical safety, material handling safety, ladder safety, scaffolding safety.
- Preparation of daily safety report and follow up Advising on statutory requirements regarding safety.
- Providing safety advice and guidance to site management and supervisor.
