- Ensure safety induction of the new employees.
- Monitoring and ensuring that activities are performed following Safety standards.
- Effective implementation of Health and safety policy of company.

- Monitor adherence to the client/group standards.
- Ensure that all accidents and incidents are properly investigated and reported.
- Check the physical condition of each fire extinguisher and pressure.
- Conducted safety trainings as per company requirements.
- Attending site safety meetings and monitoring points ensure remedial action is taken.
- Provide relevant information on Health, Safety & Environmental Policies to employees.
- Participate in safety promotions, campaigns, seminars and courses when required.
- Maintain and produce health, safety and environmental statistics and records.
- Keep up to date with all relevant legislation, regulations and codes of practice.
- Conduct daily checks of Permit to Work.
- Monitor and assist in the development of security systems/ plans.
- Maintain HSE & Training systems to auditable standards.
